

**VILLAGE OF SOUTH ELGIN**  
**MINUTES OF THE LOCAL LIQUOR COMMISSION**  
**10 N. Water Street, South Elgin, Illinois 60177**  
**September 28, 2020**

1. **Call to Order:** On September 28, 2020 a meeting of the Local Liquor Control Commissioners was called to order at 3:30 pm at Village Hall, 10 N. Water Street, South Elgin, IL 60177 by Commission Steve Ward.

2. **Roll Call:** The following were present: Commissioners Steve Ward, Lisa Guess and Jennifer Barconi. Also present was Debbie Ramsey, Recording Secretary.

3. **Discussion and Approval: Application for a 2020 Alcoholic Liquor Dealer's License in the Class A-3 Category – AANU Gas Inc., d/b/a Citgo, 96 N. LaFox** - Debbie reported that a full and complete application has been submitted along with fees for a 2020 Class A-3 liquor license which authorizes the retail sale of beer and wine in original packages only and not for consumption on the premises where the primary purpose of the premises is for the retail sale of gasoline, such as gas stations or truck stops with 10% or less of the gross retail square footage (including coolers) devoted to the retail sale of beer and wine. Trustee Guess inquired on when they were planning to open to which Debbie did not have an answer. Trustee Guess mentioned the driver's license number provided in the application had to many numbers. Debbie referred to the actual background check and it appears the applicant inadvertently repeated a number.

A motion was made by Commissioner Guess to approve the application of AANU Gas, Inc., d/b/a Citgo for issuance of a 2020 Class A-3 Alcoholic Liquor Dealers License at 96 N. LaFox pending approval of the Village Board to increase the maximum number of licenses available at the October 5, 2020 Regular Board Meeting. The motion was seconded by Commissioner Barconi. There was no further discussion of the motion. The vote as follows:

4. **Discussion and Approval: Application for a 2020 Alcoholic Liquor Dealer's License in the Class B-2 Category with an Outdoor Dining Permit – Silver Fox Management, d/b/a WeeDees, 210 N. LaFox** - Debbie reported that a full and complete application has been submitted along with fees for a 2020 Class B-2 liquor license which authorizes the retail sale of alcoholic liquors for consumption on the premise where the primary purpose of the premises is a restaurant with a restricted service bar and an Outdoor Dining Permit.

Commissioner Ward wanted to make sure both these applicants were aware that the licenses being issued expire on 12/31/20 and that fees are not prorated to which Debbie replied that they were both made aware of this prior to the applications being accepted.

A motion was made by Commissioner Guess to approve the application of Silver Fox Management, d/b/a WeeDees for issuance of a 2020 Class B-2 Alcoholic Liquor Dealers License at 210 N. LaFox pending approval of the Village Board to increase the maximum number of licenses available and approval of the Outdoor Dining Permit at the October 5, 2020 Regular Board Meeting. The motion was seconded by Commissioner Barconi. There was no further discussion of the motion. The vote as follows:
