## Program Waiver and Release of All Claims and Assumption of Risk

**Warning of Risk:** Recreational programs are intended to challenge and engage the physical, mental, and emotional resources of each participant. I further agree to waive and relinquish all claims I or my minor child/ward may have (or accrue to me or my child/ward) as a result of participating in this program against the Village of South Elgin, including its officials, agents, volunteers, and employees (hereinafter collectively referred to as "Village of South Elgin").
