Nominating petitions may be circulated for the Consolidated Election beginning on September 22, 2020.

Petitions shall be filed in the office of the Village Clerk located at Village Hall, 10 N. Water Street, South Elgin, IL 60177 from December 14, 2020 until December 21, 2020. Candidates must file the following:

- Statement of Candidacy
- Independent Candidate Petition Sheets
- Loyalty Oath (optional)
- Receipt from the filing of the Statement of Economic Interest

Statements of Economic Interest must be filed with the Kane County Clerk, 719 S. Batavia Ave., Geneva, IL 60134 no later than Monday, December 21, 2020.

To assist candidates, blank nominating petition sheets and other documents are available for pick up at Village Hall, 10 North Water Street, from 8:30 a.m. to 5:00 p.m. M-F. The Village is only providing forms for Independent Candidates. If you are running as a member of an Established Political Party or a New Political Party, you may obtain forms from the State Board of Elections. The Village and its Clerk make no representations regarding the accuracy or validity of the forms and urge candidates to consult with an attorney before taking any action based upon them. Anyone who uses them does so at his or her own risk. Blank nominating petition sheets may be photocopied or purchased from an election supply company.

Questions regarding the requirements of office, etc., should be directed to the State Board of Elections 312-814-6440, the Elections Division of the Kane County Clerk's Office 630-232-5990, or your personal attorney.
